### WHAT TO BRING:

Apparel and items should include: bed linens, towels, wash cloths for overnight campers, gym shoes, cleats, socks, shorts, t-shirts, sweats, sweatshirt, and a jacket. Bring additional clothes for free time and recreational activities (bathing suit). Softball equipment should include: glove, batting gloves (optional), and bat (optional). Catchers should bring their own catcher's equipment, if possible.

#### **INSURANCE:**

Accidental death and dismemberment coverage is provided according to schedule and with a maximum principal sum of \$1,000; medical expense coverage is provided with a maximum of \$50,000. Claims up to \$250 per claim will be paid on the excess basis, meaning that family or employer group coverage must pay its maximum first. This refers to medical expenses incurred because of injury related in any way to my child's participation in, attendance at, activities at, or incidental to camp activities. Hernias are not covered. The contracting of illness of disease by camper is not covered under this plan. Payment for medication and/or hospitalization needed by camper as a result of illness of disease is the responsibility of the camper and his/her parents. Any additional coverage desired will also be the responsibility of his/her parents.

Softball Camp registration will take place from 3:00 - 4:00 p.m. on Sunday, July 12th. Late arrivals will be accepted on Sunday.

### **CAMP STAFF:**

Kris Ganeff (formerly McCleary) graduated from the University of Notre Dame in 1999 with a degree in History. Ganeff was drafted by the Virginia Roadsters of the Women's Professional Softball League following her Notre Dame career in '99, but the former Irish MVP and team captain chose to continue her softball career as an assistant coach at UNLV in 2000 and 2001. She completed her Notre Dame playing career by earning all-BIG EAST and all-Mideast Region honors in 1999. Ganeff is entering her 8th season at Notre Dame and tenth in the Division I ranks.

Lizzy Lemire graduated from the University of Notre Dame in 2001 with a degree in Sociology and CAPP. Upon graduation, Lemire was selected to the United States National Team. The former Big East Player of the Year and team captain received her Masters in Sports Management from the University of Massachusetts in 2003. Lemire is entering her fourth season at Notre Dame and fourth in the Division I ranks.

#### SITE:

The setting for the Notre Dame Summer Girls Softball Camp is the nationally renowned campus of the University of Notre Dame, located on the outskirts of South Bend, Indiana, 90 miles east of Chicago on the Indiana Toll Road.
